Perch Base Minutes September 9, 2017

The monthly meeting of Perch Base was convened at Dillon's Restaurant, in Glendale, AZ at 1200 hours, 9 September 2017. The meeting was called to order by Howard Doyle Jr., Acting Commander.

The first item of business was a call for approval of the August Base meeting minutes. A motion was made to approve the minutes, which was seconded and approved by voice vote.

David Heighway read the Treasurer's report.

The base welcomed new member Richard Hicks.

OFFICERS REPORTS

Communications Officer/Historian – Chuck Luna

Don Unser reported on Chuck's behalf that the deadline for the MidWatch is Friday, Sept. 15, 2017

Commander – Howard Doyle Jr.

Howard reported since the Base Commander has passed away, he talked with USSVI regarding the protocol to be used for a new Commander. He was told that the Vice Commander would step into the position of Base Commander, and that a special election would be held for Vice Commander. The Board agreed that Howard be the Base Commander. The base members agreed

with this decision and the following members were nominated for Vice Commander and each accepted their nomination: Rich Simmons, Glenn Posniack and Chuck Emmett. A FlashTraffic will be put out for any other nominations. Don Unser announced that all Board Directors need backups and encourage members to participate. Ballots will be sent out for the election in October and the results will be announced at the November meeting, which will take place at the Veterans Parade in Phoenix. The installation will take place in December.

Chief Of The Boat – Carl Miner

Carl reported that he had fixed the bolts on the trailer and inspected the float. He is also going to check the sound system on the float as there were issues during the last parade. He also checked all the decals on the boat.

Treasurer – Dave Heighway

Dave had nothing more to report.

Storekeeper – Herb Herman

Herb announced that he will be ordering old challenge coins and calendars and has a sign-up sheet for those who want to order any of these items. He also has vest clips for sale and Dolphin decals for cars and trucks.

Webmaster – Dan Marks

The only major change to the website during the past month has been the postings related to the passing of Richard Kunze. Other routine updates during the past month included updating the Sailing Orders page, including Governor Joy's VA Death Benefits luncheon, and adding a USS Phoenix (SSN-702) shirt promotion to the homepage. Flash Traffics and meeting minutes uploaded, Lost Boat notices and Half Staff notices posted and links updated. The State Farm Insurance Policy and scholarship documentation have been archived. The 2018 National Convention Cruise dates have been added to the calendar. Similar updates have been maintained on the Perch Base Facebook Group.

During August, there were approximately 1,244 page views on the Perch Base website during 484 sessions by 314 users based on Google Analytics. These numbers are comparable to last month and seem to be typical. Approximately 84% of the sessions originated in the US, and the remaining 16% were widely scattered around the world. Approximately 60% of the sessions were from locations within Arizona. Another 8% were from locations in California and 3% from New Jersey. The Homepage accounted for the largest percentage of the page views this month (55%,) exceeding the Glossary (28%) and the Eternal Patrol page (4%) and the Richard Kunze memorial (3%) in that order

Membership – Jim Andrews

Jim reported that October 1st, is the start of membership dues for next year. He will be sending out letters later in Sept., to all members, reminding them that they need to pay their dues. He also reminded the members that if they paid their dues during the month of October, they would be eligible for the Early Bird Contest. The winner of the Early Bird Contest would not have to pay

their 2019 dues. He also noted that Tax Free donations are to be made to the Perch Base Foundation. Credit cards will be accepted for dues, but only during the regular meetings. Perch Base can accept donations also, but they're not Tax Free. Jim also mentioned that if any members changed their address or email address, to please notify him, so he can update National Records.
