

The regular monthly meeting of the Arizona Submarine Veterans Perch Base was convened at American Legion Post #62 Peoria, AZ at 1300 hours, 8 May 2004. The meeting was called to order by the Base Commander – Glenn Herold.

Base Chaplain Howard Doyle led the members in a prayer of Invocation. The members were then led in the "Pledge of Allegiance" followed by a reading of the "Purpose of the Organization", Dedication, a Moment of Silence for our departed shipmates and the "Tolling of the Boats" ceremony for submarines lost during the month of May.

According to the sailing list, there were 36 persons at the meeting – this total included members of the Arizona Pigboater Chapter of Submarine Veterans of WWII. Those present welcomed our guests and new members– Shipmates Gary Kahler, Brian Pelegrini, and Nick Leer. Gary, Brian and Nick introduced themselves and gave the mem-

bers a brief description of their submarine experiences. They were all given a resounding welcome from the members.

Perch Base Members also welcomed members of the Arizona Pigboater Chapter – Submarine Veterans WWII with a special welcome to Jack Richardson, 2002-2003 National President – Submarine Veterans of WWII.

A motion was made and seconded that the minutes from the April meeting be approved as published in the Base Newsletter "The MidWatch." The motion carried by voice vote.

Treasurer, Robert May, reported the Base's financial status as of the first day of May, 2004.

A motion was made and seconded to accept the Treasurer's report as read. The motion carried by unanimous voice vote.

REPORTS BY OFFICERS AND COMMITTEE CHAIRMEN

Base Vice Commander – Tim Moore had nothing new to report.

Base Chief of the Boat – Bob Gilmore announced that the American Legion Post 62 will hold its election of officers on the 18th of May. Eligible members should cast their ballot on that date.

Base Chaplain – Howard Doyle reported that he had been in contact with Roger Cousin and his wife Lee. Roger is recovering from his surgical procedure and doing well. Jim Newman also indicated that Roger and Lee are off on a trip to the East Coast and wanted everyone to know they would be out of contact during their venture.

Membership Chairman – Ramon Samson reported that current Perch Base membership is at 150 members.

Past Base Commander and USSVI Western Regional Director – Dave Harnish reviewed the results of the Mid-Year meeting of the USSVI Board of Directors. One of the main issues affecting most members was a decision to change the dues structure for membership in the organization. Annual dues will be increases for \$10 to \$20 starting in September 2004. After the Board of Directors studied mortality tables used by the life insurance industry to project life expectancy, they elected to also increase the one time fee to become a Life Member. This fee is based on a member's age and will become effective January 1st, 2005. At that time, the dues structure will be as follows:

Age 45 or younger	-	\$500
Age 46 to 55	-	\$400
Age 56 to 65	-	\$300
Age 66 to 75	-	\$200
Age 76 and older	-	\$100



For the Veteran . . .

Q: How does the Bush administration show support for the US Military?

A: Since taking office in 2001, the Bush administration has proposed the following actions:

- \$1.5 billion in cuts to military family housing, schools and child care centers
- \$200 million in funding cuts for schools near military bases
- Doubling the prices veterans pay for prescriptions
- Cutting veteran's medical care by suspending VA health center enrollments
- Reducing "imminent danger pay" from \$225 to \$150 per month
- Reducing family separation pay from \$250 to \$100 per month

Dick Caraker (Perch Base Member and Member of the Pigboater's Chapter of Submarine Veterans WWII) took







This Old Boat . . .

OK, shipmates, true to my statement in the May issue, no more "This Old Boat." I'll try and come up with something that might generate a little more interest. Any suggestions?

But, first some answers. Last month's boat was sneaky. It was a WW II Japanese boat!

The submarine was a "Kaichu" Type, specifically the RO-33. I removed the hull number from the picture but they were usually painted on the sail.



The RO-33 showing bow anti-submarine net cutter.

These double-hull medium displacement boats were derived from the Kai-toku-chu (KT) type. They were constructed at four shipyards in two variants, the K.5 (RO-33 class) and the K.6 (RO-35 class), from 1934 to 1944. The later and more numerous K.6 variant were armed with the 21-inch oxygen-propelled Type 95 submarine torpedo and a 3.25-inch (80-mm) deck gun. Allied ASW measures took a heavy toll of the type. The RO-50 was the only ship of the type to survive the war and was surrendered at Sasebo.

NEW BUSINESS

Dave Harnish took the floor and briefed the members on additional items from the mid-year meeting of the USSVI Board of Directors. A new procedure has been implemented to allow for members with internet access to cast their annual vote on line. The justification for taking this approach is based on the annual cost for printing, and mailing ballots to each member. The cost to the national organization alone was over \$8,000 last year and this didn't include the costs at the Base level. Anyone interested in the On-Line Voting should make sure their personal data is current by updating it online. To vote on line, each member must provide an email address and the hull number of their qualification boat.

Dave also reported that a discussion was held regarding the possibility of merging the Submarine Veterans of WWII organization with USSVI. The fact that US Submarine Veterans WWII is nationally chartered and USSVI is not precludes the merger of the organizations without significant amounts of restructuring. However, a USSVI committee was formed to pursue the most effective way of bringing the two organizations closer together.

Jack Richardson informed the members of the availability of scholarship monies for Submariner's children through the Dolphin Scholarship Fund which was largely funded by the scholarship funds from the Submarine Veterans of WWII. Members were also reminded of the scholarship monies available to the submariner's children and grandchildren through the US Submarine Veterans Charitable Foundation's Scholarship Program.

GOOD OF THE ORDER

USSVI Western Regional Director - Dave Harnish asked all Perch Base Holland Club members to assemble front and center. After which, Dave called forward Shipmate Emil Schoonejans. Emil was then inducted into the USSVI Holland Club as a member in good standing who qualified in submarines more than 50 years ago.

After the induction ceremony, Emil was given a Holland Club Patch, membership card, lapel pin, coffee mug, certificate, Perch Base patch and letter from Bill Britt (President of the USSVI Holland Club). The existing Holland Club members welcomed Emil into their group and the membership showed him their appreciation with a resounding round of applause.

50/50 DRAWING

The 50/50 drawing was held and Ed Brooks was the winner. Ed donated the winner's share back to the Perch Base Treasury.

DID YOU KNOW?

Q: Was the War in Iraq justified to protect our national security?

A: No. President Bush told America that Iraq had Weapons of Mass Destruction (WMD's) that could be used against the U.S. No such weapons have been found. In January 2004, Bush's own U.S. weapons hunter David Kay said, "I don't think they existed." [Reuters, January 24, 2004]

Q: Was the War in Iraq part of the War on Terrorism?

A: No. Both Secretary of State Colin Powell [NBC News, January 8, 2004] and President Bush [White House Transcript, January 31, 2003] admit there is no evidence tying Iraq to the terrorism of 9/11.

Q: Aren't we safer now that Saddam is gone?

A: Bush decided to invade Iraq long before 9/11. Bush's own appointed cabinet member, Paul O'Neill, said that regime change in Iraq was the main topic at the very first meeting of Bush's National Security team - a full eight months before 9/11. [USA Today, January 12, 2004] O'Neill said, "It was all about finding a way to do it. That was the tone of it. The president saying 'Go find me a way to do this.'" The Philadelphia Daily News reported [Philadelphia Daily News, January 27, 2003] that Rumsfeld and Cheney began making the case for an American invasion of Iraq [PNAC January 26, 1998 letter to President Clinton] as early as 1997 - nearly four years before the September 11th attacks."

Q: What has the War in Iraq cost America?

A: Over 500 U.S. soldiers killed and nearly 3,000 wounded. [As of January 24, 2004] It has seriously damaged relationships with most of our European allies and the United Nations, and the loss of the moral authority that came with our history of fighting aggressors rather than being aggressors. Over \$95 Billion and counting [As of January 24, 2004], which could have been better spent on education or health care or...we could have not spent it at all.


The War in Iraq

U.S.S. Gudgeon (SS-211) 78 men lost

After shakedown along the California coast, *USS GUDGEON* (SS-211) sailed north 28 August, heading for Alaska via Seattle. On her northern jaunt the new submarine inspected Sitka, Kodiak, and Dutch Harbor for suitability as naval bases. Continuing to Hawaii, she moored at the Pearl Harbor submarine base 10 October. Training exercises and local operations filled *GUDGEON*'s time for the next 2 months. When the Japanese struck at Pearl Harbor 7 December she was at Lahaina Roads on special exercises, but returned to base immediately.

America's Pacific Fleet had been seriously damaged by the sneak attack on Pearl Harbor but powerful strength remained as *GUDGEON* and her fellow submarine soon offered convincing proof. On 11 December *GUDGEON*, in company with *USS PLUNGER* (SS179), sailed from Pearl Harbor on her, and America's, first submarine offensive patrol of World War II. When she returned some 51 days later, *GUDGEON* had contributed two more impressive "firsts" to the Pacific submarine fleet. She was the first American sub


The raffle for the Elgin Clocks was held and both first and second drawings were won by Sue Shumann.

marine to patrol along the Japanese coast itself, as her area took her off Kyushu in the home islands. And on 27 January 1942 *GUDGEON* became the first U.S. Navy submarine to sink an enemy warship in World War II, submarine *I-173*. The Japanese submarine had just returned from a patrol which took her well into American water off the coast of California and Washington.

On her second war patrol, 22 February to 15 April 1942 *GUDGEON* scored kills on two unknown marus, both freighters, 26 and 27 March. She then checked into drydock for overhaul, but undocked 3 weeks early and readied for sea in a remarkable 40 hours to participate in the momentous Battle of Midway. Departing Pearl Harbor 18 May, *GUDGEON* took station off Midway as part of the submarine screen which encircled the two giant fleets clashing there. Although she had a ringside seat for the action, which saw Japan handed its first naval defeat in 350 years, *GUDGEON* was prevented from offensive ac-



tion by the confusion of battle and the possibility of mistaken identity. She returned to Pearl Harbor 14 June.

Departing for her fourth patrol 11 July, *GUDGEON* sank 4,858-ton *Naniwa Maru* in a night submerged attack 3 August, her only kill of the patrol. An aggressive attack on a four-ship convoy 17 August seriously damaged two marus before the patrol ended at Fremantle, Australia, 2 September. Now a part of the Southwestern Pacific submarine forces, *GUDGEON* sank 8,783-ton *Choko Maru* 21 October during her fifth war patrol, 8 October to 1 December, and carried out a daring attack on a seven ship convoy 11 November, torpedoing several ships but sinking none. The submarine's sixth war patrol (27 December 1942 - 18 February 1943) was unsuccessful terms of ships sunk, but she carried out two special missions. On 14 January 1943 *GUDGEON* successfully land six men on Mindanao, Philippines, to carry out the vital guerrilla resistance movement there. Returning from her patrol area, *GUDGEON* was diverted to Timor Island 9 February, and

the following day rescued 28 men-Australian, English, Portuguese, and Filipino for passage to Fremantle.

GUDGEON's seventh war patrol netted her two more Japanese ships before she ran out of torpedoes and had to return to Australia. On 22 March she sank 5,434-ton *Meigen Maru* as well as seriously damaging two other ships in the convoy. Five days later *GUDGEON* took on 9,997-ton tanker *Toko Maru* in a night surface attack punctuated by bursts of gunfire as the Japanese ships spotted and fired on the submarine. It took five torpedoes to sink *Toko Maru*, and most of *GUDGEON*'s crew enjoyed the rare treat of watching her slide into the depths.

On her eighth war patrol, conducted as she sailed from Australia to Pearl Harbor 15 April to 25 May 1943, *GUDGEON* chalked up three more kills. Her first came 28 April as she sank *Kamakura Maru*, a former ocean liner. The 17,520-ton transport was the largest Japanese transport, and one of the largest enemy ships sunk by an American submarine. Special operations interrupted *GUDGEON*'s patrol as she landed six trained guerrilla fighters and 3 tons of equipment for the guerrilla movement on Panay 30 April. After sinking a small trawler, *Noko Maru*, with her deck guns 4 May, *GUDGEON* battle-surfaced again that same day and left a coastal steamer burning and settling. Eight days later, 12 May, she torpedoed and sank freighter *Sumatra Maru*. Returning to Pearl Harbor, the veteran submarine was sent to San Francisco for badly needed overhaul, her first since commissioning 2 years earlier.

A refreshed sub and crew departed Pearl Harbor for their ninth war patrol 1 September 1943. Before returning to Midway 6 October with all torpedoes expended, *GUDGEON* had sunk TAI AU MARU and seriously damaged several others. Heading along the China coast for her 10th war patrol (31 October-11 December), *GUDGEON* chalked up two more marus. Early in the morning of 23 November she spotted a convoy of four ships and closed for attack. *GUDGEON* fired a spread of six torpedoes with gratifying results. Frigate,

Submarines of Today

Last of the "Seawolf Class" is Launched

The Department of Defense announced on June 3 that the Navy's newest Seawolf class nuclear-powered submarine Jimmy Carter was christened Saturday, June 5 during an 11 a.m. ET ceremony at General Dynamics Electric Boat in Groton, Conn.



The submarine, Jimmy Carter, honors the 39th president of the United States. Carter is the only U.S. president to qualify in submarines. He has distinguished himself by a lifetime of public service, and has long ties to the Navy and the submarine force. He is a 1946 graduate of the U.S. Naval Academy, served as an officer aboard submarines while in uniform, and served as commander-in-chief from 1977-1981. Carter's statesmanship, philanthropy and sense of humanity have made him one of the most influential Americans of the late 20th century.

James R. Schlesinger, a former secretary of both defense and energy and former director of the Central Intelligence Agency, will deliver the ceremony's principal address. Schlesinger served under Carter as the nation's first secretary of energy. Rosalynn Carter will serve as sponsor for the ship named for her husband. In a time honored Navy tradition, Carter will break a bottle of champagne across the bow to formally name the submarine Jimmy Carter.

The Jimmy Carter is the third and final submarine of the Seawolf class. As the most advanced submarine in the Seawolf class, the submarine will have built-in flexibility and an array of new warfighting features that will enable it to prevail in any scenario, against any threat – from beneath Artic ice to shallow water. Differentiating the Jimmy Carter from all other undersea vessels is its multi-mission platform (MMP), which includes a 100-foot hull extension to enhance payload capability. The MMP will enable the Jimmy Carter

to accommodate the advanced technology required to develop and test new generation of weapons, sensors and undersea vehicles for naval special warfare, tactical surveillance and mine-warfare operations.

Cmdr. Robert D. Kelso is the ship's prospective commanding officer with a crew of approximately 130 officers, chiefs, and enlisted personnel. The 12,130-ton Jimmy Carter is 453 feet in length, has a beam of 40 feet, and can operate at more than 25 knots submerged. Upon commissioning in 2005, the Jimmy Carter will join the U.S. Pacific Fleet.

Wakamiya, hit by one of the deadly "tin fish" broke in two, sinking almost immediately. A tanker and a freighter were also hit but managed to escape. *GUDGEON* closed in to administer the kill to transport *Nekka Maru*.

Several attacks but no kills highlighted *GUDGEON*'s 11th war patrol. On 2 February 1944, she sighted a damaged carrier with two escorts. *GUDGEON* closed for attack, but the escorts spotted her in the glassy smooth sea and attacked. A down-the-throat shot with four torpedoes temporarily discouraged the destroyers and allowed *GUDGEON* to seek deep water and safety, but when she surfaced the Japanese men-of-war were gone. Later in the same patrol *GUDGEON* was forced to try another down-the-throat shot at an enemy escort, but no hits. She returned to Pearl Harbor 5 March 1944.

GUDGEON sailed for her 12th war patrol 4 April 1944. The battle-tested submarine stopped off at Johnston Island 7 April, and was never seen or heard from again. On 7 June 1944, *GUDGEON* was officially declared overdue and presumed lost. Captured Japanese records shed no light on the manner of her loss, and it must remain one of the mysteries of the silent sea.

During her 3-year career, *GUDGEON* earned herself a proud place in the Pacific submarine fleet. Her total tonnage sunk, 71,047, placed her 15th on the honor roll of American submarines, and she had accounted for a total of 12 confirmed kills.


For her first seven war patrols *GUDGEON* received the coveted Presidential Unit Citation. She earned 11 battle stars for World War II service.
