
OLD BUSINESS



Volunteers help in moving residents from their units to Liberty Hall for these activities. They also play cards with the residents and help serve ice cream, pop corn, etc.



Eternal Patrol June 18, 1945

Editors Note: *Less we forget, each month, one boat on eternal patrol will be highlighted in this newsletter. Sailors, rest your oars.*

U.S.S. Bonefish (SS-223) 85 men lost

In company with USS TUNNY (SS-282) and USS SKATE (SS-305), USS BONEFISH (SS-223), departed Guam on 28 May 1945 to conduct her eighth war patrol. This coordinated attack group under Cdr. G.W. Pierce in TUNNY, which was

one of three groups then penetrating the Japan Sea, was ordered to transit Tsushima Strait on 5 June 1945, and to conduct offensive patrol in the Sea of Japan off the west central coast of Honshu. This area was further subdivided, with BONEFISH assigned to patrol the northern portion.

BONEFISH successfully transited Tsushima Strait, and made rendezvous with TUNNY on 16 June 1945, in position 36°40'N, 135°24'E. BONEFISH reported she had sunk one large transport and one medium freighter to date. On the morning of 18 June, TUNNY and BONEFISH rendezvoused in the vicinity of 38°15'N, 138°24'E. BONEFISH asked permission to conduct a submerged daylight patrol in Toyama Wan, in the mid part of western Honshu, and having received it, departed for Suzu Misaki. She was never seen or heard from again.

BONEFISH, in accordance with the operation order, was to rendezvous with the other eight submarines of the three groups, in 46°50'N, 140°E at sunset on 23 June 1945, in preparation for the transit on 24 June of



La Perouse Strait. BONEFISH did not make this rendezvous, and after the other eight vessels had successfully transited La Perouse Strait, TUNNY on 25 and 26 June waited off the entrance to the Strait and unsuccessfully tried to contact BONEFISH.

Provisions were made in the operation order governing this patrol group for submarines in case of necessity to proceed to Russian waters to claim a 24-hour haven, or to submit to internment in extreme need, or for them to make their exit from the Japan Sea prior to or after 24 June. When all of these possibilities had been examined, and she had not been seen or heard from by 30 July 1945, BONEFISH was reported as presumed lost.

Japanese records of antisubmarine attacks mention an attack made on 18 June 1945, at 37°18'N, 137°25'E in Toyama Wan. A great many depth charges were observed. This undoubtedly was the at-

In total, this boat sank 31 enemy vessels, aged 7, for 42,000 tons. She began her marine Force with a patrol in the South 1943. She sank three freighters, two and damaged a fourth freighter. On her Celebes Sea and near Borneo, BONEFISH sank a very large tanker, and damaged a second large tanker. Seas for her fourth patrol and sank two while she damaged a sub chaser.

Postwar information also reveals that on tanker which she sank, BONEFISH hit

This boat's fifth patrol was in the same small freighters, a large tanker and five damaged a second tanker. BONEFISH covered a South China Sea area in her sixth patrol, and sank two large tankers and a freighter during September and October 1944. She also damaged two medium freighters. Then, after a thorough overhaul and the installation of much new equipment in San Francisco, BONEFISH made her seventh patrol in the East China Sea. She had only one attack opportunity and did no damage. However, she took two Japanese prisoners from a downed enemy plane, and performed reconnaissance work on the southern end of Korea.

BONEFISH was awarded the Navy Unit Commendation for the period of her first and third through sixth patrols.

Short Facts

Probably the most damaging spread of torpedoes ever fired was launched from the Japanese submarine I-019 (LCDR Kinaashi) at 1444 hrs. on September 15, 1942. Five torpedoes hit sinking the USS WASP, USS O'BRIEN and badly damaging the USS NORTH CAROLINA. For this fete LCDR Kinashi was promoted to Rear Admiral. He was later lost on another submarine in 1944.



South American Submarines Enhance U.S. Navy's Fleet Readiness

NORFOLK, Va. (NNS) — In a joint agreement with Colombia and Peru, one diesel-electric submarine from each of these two countries is deploying to the United States in April to enhance fleet readiness by participating in a number of naval exercises.

BAP Antofagasta (SS 32) from Peru and ARC Pijao (SO 28) from Colombia have begun a deployment to participate in major Atlantic Fleet exercises, including Composite Training Unit Exercise (COMPTUEX) and Joint Task Force Exercise (JTFEX) for the USS Theodore Roosevelt (CVN 71) Carrier Strike Group.

The first training opportunity to utilize these diesel-electric submarines as opposition forces is Smart Search '05, an annual anti-submarine warfare (ASW) exercise, which began April 11.

"Providing the fleet the chance to train with actual diesel submarines from partner nations - vice using our SSNs in a simulated role - will add important realism and enhance ASW skills," said Juan Fernandez, tactical director for analysis, Commander, Submarine Force, U.S. Atlantic Fleet (COMSUBLANT).


The proliferation of diesel-electric submarines by potential adversaries is a growing security concern, which is why improving the U.S. Navy's ASW skills is a high priority, according to Fernandez.

"This deployment by our South American partners is a cooperative effort with mutual benefit for all parties," Fernandez said. "We will enhance our ASW capabilities, and they will advance their readiness and skills. Throughout the exercises, we will also improve interoperability between our navies."

In addition to fleet training, Antofagasta and Pijao will support the Office of Naval Research's ASW research and development programs.



This cooperation is based upon a long-standing relationship between the United States and South American nations. For more than 45 years, UNITAS, the premier naval exercise in the region, has been a uniting event, bringing nations together to enhance the region's defense and promote military interoperability.

Since 2002, South American diesel-electric submarines have been integrated into various U.S. naval exercises, allowing operators to search for real diesel-electric submarines. Commander, U.S. Fleet Forces Command has designated COMSUBLANT as the program executor and overall coordinator to work with Commander, U.S.

Naval Forces Southern Command. Each deployed submarine will spend two to five months in the United States, with most of the time underway for operational training.

Naval Station Mayport, Fla., will be the temporary homeport for Antofagasta and Pijao during their deployment.

List of submarine classes of the United States Navy

Sure, we all served on them but do we know ALL of them? This comprehensive list all the classes of U.S. submarines.

Submarines of the United States Navy are built in classes, using a single design for a number of boats. Minor variations occur as improvements are incorporated into the design, so later boats of a class may be more capable than earlier. Also, boats are modified, sometimes extensively, while in service, creating departures from the class standard. However, in general, all boats of a class are noticeably similar.

Occasionally, a class will consist of a single ship as a prototype, or for experimental use; an example is USS Albacore (AGSS-569), which used an unprecedented hull design. In this list such single boat 'classes' are marked with '(unique)'.

- A WWII fleet boat with many technical changes based on wartime experience and post-war development.
- USS Albacore (AGSS-569) (unique)
 - Built primarily to test the streamlined hull form that is now standard, she later served as a research and development test bed.
- USS Nautilus (SSN-571) (unique)
 - The USN's first nuclear powered submarine, her hullform was based on that of a fleet boat
- Sailfish (SSR-572) class
 - Purpose built radar picket submarines.
- Grayback (SSG-574) class
 - Cruise missile submarines.
- USS Seawolf (SSN-575) (unique)
 - Designed and built to test a liquid metal reactor
- Skate (SSN-578) class
 - The first attempt to build a standard nuclear submarine, she was essentially a nuclear Tang. This was the last class designed with surface operations in mind.
- Barbel (SS-580) class
 - A diesel submarine based on the Albacore. These were the last nonnuclear-powered submarines built for the USN.
- Skipjack (SSN-585) class
 - The first class of nuclear submarines to use the whale-like Albacore hull.
- USS Triton (SSRN/SSN-586) (unique)
 - A nuclear powered radar picket submarine.
- USS Halibut (SSGN/SSN-587) (unique)
 - A purpose built cruise missile submarine. When cruise missiles were superceded in the strategic role by ballistic missiles, she was redesignated a fast attack (SSN) submarine.



- This class was known as the Thresher class prior the loss of its lead ship
- USS Tullibee (SSKN/SSN-597) (unique)
 - The Tullibee was a prototype “hunter-killer” (SSKN) submarine, the nuclear powered equivalent of the Barracuda class. She was built to test the new bow sonar and amidships torpedo room configuration that is now standard for US submarines. Also like the Barracuda and Mackerel classes she was also an attempt to build a smaller cheaper submarine. Like all such attempts she proved inadequate in service and was not repeated.

- Ethan Allen (SSBN-608) class
- Lafayette (SSBN-616) class
- James Madison (SSBN-627) class
- Sturgeon (SSN-637) class

 - The Ohio class is unusual in having two types of submarine with the same class name and number. This is caused by the conversion and redesignation of the first four submarines from SSBN to SSGN

 - The Seawolf class have numbers out of the traditional sequence because they were numbered according to the name of the development project, ‘Attack Submarine’ (SSN) for the ‘21st Century’, hence SSN-21.

PEARL HARBOR, Hawaii (NNS) — The Chief of Naval Operations announced USS La Jolla (SSN 701) Command Master Chief CMDCM Rick Atkins as the Naval Submarine Frank A. Lister Award winner for Outstanding Chief of the Boat (COB) May 6.

The Master Chief Frank A. Lister Award recognizes a submarine chief of the boat who has displayed exceptional leadership and motivation to his crew. One award is presented annually to a submarine senior or master chief petty officer while serving as, or having recently served as, chief of the boat in a submarine during the nomination period.



“This award could have been any chief of the boat on the waterfront,” said Atkins.

The Los Angeles native is a 20-year veteran in the Navy and said despite his experience, his success is attributed to the crew members that he mentors, as well as others who mentored him.

“If things went my way and there was a plaque, it would have every Sailor on La Jolla on it,” he said. “They helped me become what I am today.”



Atkins believes what makes a chief of the boat great is taking care of his people.

“Without the crew, the submarine is pipes and metal. Sailors are the heart and soul of a submarine,” said Atkins. “If you take care of them, it boosts their efficiency to complete the mission.”

Over the last two and a half years, Atkins has been a part of the driving force of many unit awards that La Jolla has won, including the Commander, U.S. Pacific Fleet Golden Anchor award, Submarine Squadron 1’s Naval Special Warfare Excellence Award and the Tactical ‘T’ award.

Once again, Atkins attributed his successful tour to the crew.

“It is very rewarding to watch my crew do incredible things on an everyday basis,” he said. “Nothing is better and more rewarding than being a COB.”


