

## September 2008 Regular Meeting Minutes

The regular monthly meeting of the Arizona Submarine Veterans, Perch Base was convened at the American legion, Post 35, Chandler AZ at 1255 hours on 20 September 2008. Jim Denzien, Vice Commander, called the meeting to order.

It was well received and there is a list of potential members. The membership made a motion to support the formation of a new East Valley Base and provide \$500.00 as seed money if started. The motion was

seconded and passed by voice vote. Perch Base will be participating in the Veterans Day parades in both Anthem and Phoenix.
