Since the last meeting, memorials to the losses of the USS Robalo (SS-273), and the USS Grunion (SS-216) were posted to the website. Pictures have been posted to the website for the USS Scorpion model presentation by Mike Keating at MEPS. The Eternal Patrol of Herb Coulter was posted. Notification of the Half Staff proclamation for the Chattanooga shootings and the proposed challenge coin were also posted. Our Facebook page was updated for the same events.

During July, there were approximately 3,298 page views on the Perch Base website during 2,249 sessions by 1,976 users based on Google Analytics. Approximately 42% of the visits originate in the US, 19% from Russia, 2% from the United Kingdom and the remaining 37% are not specified or widely scattered around the world. Approximately 11% of the visits are from locations within Arizona. The Homepage accounted for the largest (64%) percentage of the visits, exceeding the Glossary (30%.) There were 28 (1%) visits to the Eternal Patrol page. These statistics are comparable to the last several months..
