Laws 2014, Fifty-first Legislature, Second Regular Session, Chapter 227 (SB1401) authorizes the Department of Administration (ADOA) to provide for the placement of a memorial dedicated to the commemoration of United States submarine veterans in Wesley Bolin Plaza.

Per the provisions of A.R.S. § 41-1363, ADOA has recognized the Arizona Silent Service Memorial Foundation as the proponent of the memorial.

As of this date: the Legislative Governmental Mall Commission approved the memorial on March 4, 2016; the ADOA General Services Division (GSD) has reviewed the concept and determined the most appropriate location for the memorial; the Arizona Historical Advisory Committee has made recommendations regarding the historical integrity of the memorial; GSD has approved the conditions of the design, dimensions and location of the memorial; and, the final construction plans have been reviewed for compliance with applicable code requirements.

Based on the abovementioned progress, I approve the design and location of the memorial; furthermore I direct GSD to prepare a contract with the Arizona Silent Service Memorial Foundation per the requirements of A.R.S. § 41-1363. Upon execution of the contract, ADOA will be able issue a Notice to Proceed for construction of the memorial.
