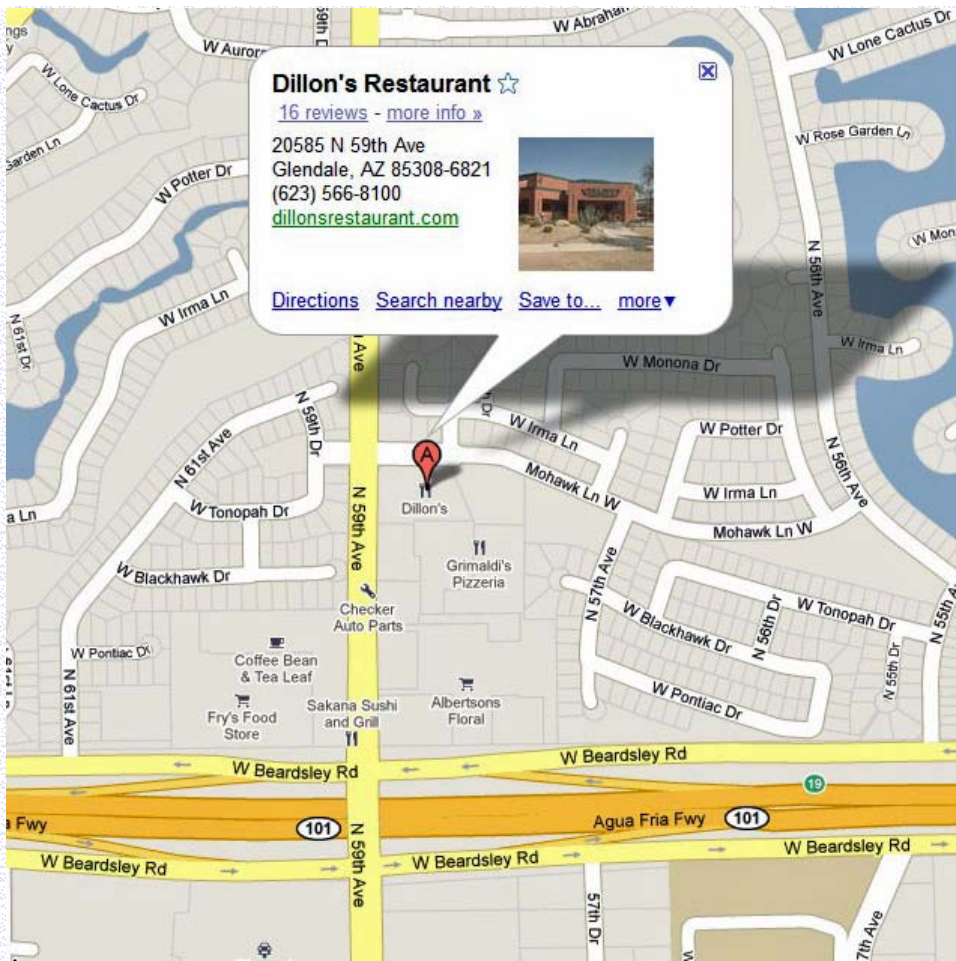
While adequate as a meeting place, the American Legion has not always been reliable on meeting days.
