Brian Steffen, USSVI National Service Officer, just got off the phone with Home Depot corporate offices and found out that Home Depot now only gives discounts to active duty, active reservists and "service connected" veterans. The prior rules were that any vet got the discount. Your retired ID card will not be enough to get any discounts it must be one of the above. To clarify the "service connected" requirement, any veteran that has a service connected disability incurred as a result of service in any of the branches of service and assigned a (%) from the VA after claims process and have a VA ID card with "Service connected" under your picture.

Remember if you were ever injured or hospitalized or medically treated during your career you are eligible for putting in a claim with the VA to receive compensation, if approved, for those ailments.
