Jon Jaques made motion to accept the appointments, second by Steve Bell. Motion approved unanimously. Appointments and Committees approved.

**USS BONEFISH** – END4 Cdr Art Glover ask for that the USS Bonefish SS-582 be added to the list of Lost Boats included in our Lost Boats Tolling Ceremony.

A brief history of what occurred during the incident that virtually made the Bonefish unrepairable and resulted in the loss of three crew members was given as listed below.

On April 24, 1988, the USS Bonefish SS-582 had a catastrophic fire while submerged during an exercise with the Guided Missile Frigate USS Carr off the Atlantic Coast of Florida. This fire was caused by seawater leaking onto cables and electric buses in a battery-supply cableway. The arcing then caused an explosion, which flashed into a fire within minutes, with the temperature in the battery space reaching 1,200° Fahrenheit.

The heat was so intense that it melted the soles of the shoes of the crewmembers in that were in that space. Bonefish surfaced, and the captain ordered the crew to abandon ship.

Over the next three hours the crews of a whaleboat from *Carr* and helicopters from both Carr and the <u>aircraft carrier</u>, <u>USS John F. Kennedy</u> rescued 89 men.

Three crewmembers – Lieutenant Ray Everts, Radioman First Class (RM1) (SS) Bob Bordelon, and Yeoman Third Class (YN3) (SS) Marshal Lindgren – died due to the fire.

Their bodies were recovered by members of the Frigate USS McCloy.

The Bonefish was towed to Charleston, SC where Naval authorities deemed the damage to Bonefish to be too extensive to warrant repair and thus decided to decommission and scrap her.

Les Altschuler made a motion to include the USS Bonefish in the Tolling of the Boats list. Second by Ken Nichols.

Following a discussion, a vote was called for to approve the addition of the USS Bonefish SS-582 to the list of Lost Boats.

The vote was approved unanimously. Wayne Standerfer will talk with Warren Branges about including the Bonefish to his ceremony list and take care of notifying the membership.

**NOTE:** <u>This vote to add the USS Bonefish SS-582 to the Lost Boat Tolling Ceremony was</u> <u>removed/rescinded by the National BOD's at membership request on 09/08/2020</u>

## **CLOSING COMMENTS FROM ATTENDEES**

Ken Nichols mentioned there is an auction of submarine memorabilia being organized for our next convention in Orlando to raise funds for the Charitable Foundation. A Central Texas Base member is donating much of the memorabilia. John Markiewicz said he was not familiar with the Orlando Convention auction, but there was a two (2) night auction planned for the Tucson Convention that would benefit next year's convention, but since the Tucson Convention was cancelled, a decision will have to be made as to where we proceed with a future auction.

Ken Earls has requested a table for the Charitable Foundation at the next convention.

Paul Hiser recommended that an advertising manager be appointed for the American Submariner Magazine. We are doing okay at present, but it would lighten the load on the magazine's editorial staff if someone were appointed.

Michael Bircumshaw said he would feel better if someone assumed this responsibility, but the AS is doing well at present.

Wayne said to let Michael make this appointment if and when he feels it becomes necessary.

Wayne Standerfer said it has been a pleasure working with Board over the last two years. They have very efficiently resolved issues as they have arisen. Many Boards in the past have not worked in unison which resulted in unwarranted problems, but that has not been the case with the present board. All of them have been not only been very cooperative, but they address issues promptly and effectively.

Steve Bell made a motion to close the meeting, Second by Tom Williams.

National Commander Wayne Standerfer closed the meeting at 1228 on August 31, 2020.
