Major activity with the website during the past month has been the addition of a promotion for the "Pinups For Vets" charity recommended by Rick Simmons at the July meeting. Based on input from the Gudgeon Base Commander, the date listed for the Gudgeon Base Picnic was updated to Saturday, September 21. Routine updates during the past month included updating the Sailing Orders page, Flash Traffics and meeting minutes uploaded, Lost Boat notices and Half Staff notices posted and links updated. Similar updates have been maintained on the Perch Base Facebook Group.

A significant change to the website has been made which changes the website from absolute to relative addresses. Although not visible to the user, the change allows the website to be displayed at our meetings or events without the availability of WIFI or internet service using a computer as the server. The webmaster investigated an apparent case of "Email Harvesting" where "bots" scan the internet for email addresses. Since there is a webpage with the @perch-base.org email addresses for the Board of Directors, the SPAM was limited to only several members of the Board.

Located and contacted 3 possible drivers for another member in Sun Lakes.

During July, there were 1,399 page views on the Perch Base website during 530 sessions by 342 users based on Google Analytics. These numbers are typical. Approximately 80% of the sessions originated in the US, 3% from the China, 2% from the United Kingdom, and the remainder were widely scattered around the world. Approximately 28% of the U.S. based sessions were from locations in Arizona, which is assumed to come from our membership. 43% of the traffic was to the home page, 41% to the Glossary, 3% to the Sailing Orders page, 2% to the Eternal Patrol page, and 2% to the Prescott Frontier Days Parade page.
