## **Webmaster – Dan Marks**

Activity with the website since the last BOD meeting included posting the photo of the First Place trophy from Honoring America's Veterans for the USS Phoenix (SSN-702) float in the 2025 Phoenix Veterans Day parade, and posting the presentation by Vice Commander Don Robertson titled "UNCLE CHARLIE'S BRASS SUBMARINE" given at the December monthly meeting. Routine updates during the past month included updating the Sailing Orders page, Flash Traffics, base correspondence and meeting minutes uploaded, Lost Boat notices and Half Staff notices posted and links updated. Similar updates have been maintained on the Perch Base Facebook Page.

During December, there were 8,720 page views on the Perch Base website during 7,084 visits by 5,482 users based on Awstats. The most page views were from the United States, followed by Japan, then China. Most of the traffic was to the home page, followed by the Glossary, Sailing Orders, then the Links page. The most downloads were the usual pages: the Historic List of Submarine Classes, followed by the Hurt Feelings Chit, then the Mabus letter.

During December, Facebook Views (The number of times your content was played or displayed. Content includes videos, posts, stories and ads.) was 1,042 and the Content Interactions (The number of likes or reactions, saves, comments, shares and replies on your content, including ads. Content can include formats such as posts, stories, reels, videos and more.) was 20. These are decreased numbers since last month, presumably due to less activities after Veterans Day. Our Facebook page has a total of 252 Followers, an increase of 3 from last month. The top post was the "USS S-4 (SS-109) Eternal Patrol Notice.
